

IAEA Guidance on the Import and Export of Radioactive Sources

The '[Code of Conduct on the Safety and Security of Radioactive Sources](#)' (the Code), in paragraphs 23-29, contains guidance concerning the import and export of Category 1 and 2 radioactive sources. In this connection, IAEA Member States developed the non-legally binding '[Guidance on the Import and Export of Radioactive Sources](#)' (the Guidance) to provide supplementary guidance on the implementation of those provisions of the Code. Paragraph 4 of the Import/Export Guidance states "*Each State should nominate a point of contact, which could be a persons or a position, for the purpose of facilitating the export and/or import of radioactive sources in accordance with the Code and this Guidance. If more than one point of contact is designated by a State, the State should indicate which point of contact should be contacted under which circumstances. States should provide the details of these points of contact to the IAEA.*"
